# **Industry Overview**



#### **THE BUSINESS ENVIRONMENT**

- In 2024, The Government approved up to \$800 billion on public construction work, which is not only set a record high, but also significantly increased by 17.87% from \$678.7 billion in 2023. It accentuated the government's emphasis on public construction.
- In order to achieve housing justice and improve the housing market, the Government has promoted the policy of building social housing for 200 thousand units in 8 years since 2017. In addition, the Government will plan to build social housing for 250 thousand units in the next 8 years from 2025. Moreover, it create a plan of town building, which combine industrial development with social welfare to create a livable environment.







#### **INFLATIONARY SPIKE AND LACK OF LABOR**

- The price index of construction has continued to hit a record high, rising year by year since 2017. The crude oil price fluctuates greatly, that lead to main materials increase. In the future, there are still carbon costs should be considered, so that the pressure on construction costs will be difficult to alleviate.
- Lack of labor has become a problem in the Industry, although the Government has opened up foreign workers to fill the basic work. However, it cannot eliminate the gap of workers who have professional skills, resulting in vacancies in the Industry still be a issue need to be solved.



### **Prospects for Future**



#### **PROSPECT**

- Directorate General of Budget, Accounting and Statistics, Executive Yuan who have predicted fixed capital will be increased by 7.17% in 2025. It is higher than the growth rate of 2024.
- The Government budgeted for public construction funds, which continued to rush. And the type of project bid was the most favorable bid, which led to strong profit growth.
